- 10 lane, 50 meter pool with separate warm down facility
Colorado Timing will be used with a 5 line scoreboard.
Deck space is limited in pool area to meet workers, coaches, swimmers, officials. Parents are asked to remain in the stands during the meet. There is ample space provided for swimmers on the pool deck. **The competition course has been certified in accordance with 104.2.2C(4) . The copy of such certification is on file with USA Swimming & Georgia Swimming. Pool depth at the start end is 5 feet and 7 feet at the turn end.**

- ELIGIBILITY:** Open to all swimmers registered with USA Swimming and Georgia Swimming and others.
- RULES:** Current USA Swimming rules will govern the conduct of this meet, unless otherwise noted herein.
- Swimmers are responsible for swimming in their assigned heats and lanes.
- Dive-over starts may be utilized at the discretion of meet management and officials.
- FORMAT:** All events are timed finals.
- The 400 IM, 400 Free, and 800 Free will swim fastest to slowest.
- SEEDING** All events will be pre-seeded with the exception of **the 400 IM, 400 Free, & 800 Free which will require a positive check-in**. Positive check-in is required for all deck seeded events 30 minutes after the start of the session in which that particular event is scheduled. **Swimmers participating in the 800 free, the 400 free and the 400 IM are asked to supply a timer.** The 400 IM, 400 free, & 800 free will be limited to the fastest 50 swimmers per event (e.g., up to 5 heats for a single event number).
- SCHEDULE:** Saturday & Sunday warm-up 8:00 AM; meet starts 9:00 AM.
Host reserves right to split sessions if time line dictates.
- CHECK-IN:** Positive check-in is required for all deck seeded events 30 minutes after the start of the session in which that particular event is scheduled.
- ENTRY FORMAT:** Submit entries in standard data format (SDIF) or Hy-tek (preferred) or on a standard meet entry form. Entries must include each swimmer's USA Swimming registration number, first and last name, age, and seed time for each event entered. A printed copy of all entries, fees, and a completed and signed liability release form must accompany the disk.

- ENTRY DEADLINE:** All entries must be **received by June 4, 2010**. Please waive signature for overnight deliveries. E-mail entries may be made to scatswimming@gmail.com provided that entry disk, hard copy, fees, and liability release form are received by the **entry deadline of June 4, 2010**. The order of events will be available in Hy-tek format at www.scatswimming.org

- LATE ENTRIES:** Late entries will be accepted on a first come/first served basis if empty lanes are available. No additional heats will be created for late entries. Any changes or entries received after the entry **deadline of June 4, 2010** will be charged on a late entry basis. Late entries will be accepted at the Clerk of Course up to 30 minutes before the session begins. Late entry fees will be doubled and late entries will be seeded with no time (NT). Late entered swimmers must present proof of USAS registration to the clerk of course.
- ENTRY LIMIT:** This meet may be limited to the first 500 entries received. Swimmers may enter **4 individual events per day**.
- ENTRY FEES:** Four dollars (\$4.00) per individual event & late entries will be double.
- SCORING:** Individual events: 11-9-8-7-6-5-4-3-2-1.
- AWARDS:** High Point Trophies for top 15 in the following age groups – 8 & Under, 9-10, 11-12, & 13-14.
- COACHES** Coaches will be required to sign in and show their USA Swimming coaches registration card for verification that all certifications are current. Coaches will be required to wear the USA Swimming Badge while on deck. At least one coach from each team must attend any coaches' meeting. **A mandatory coaches meeting will be held Saturday, June 12th, 2010 at 8:45 am.** One coach from each club is required to attend. Subsequent meetings will be arranged if needed.
- OFFICIALS:** Officials scheduled to work must check in 1 hour prior to the start of each session. All officials must wear current USA Swimming registration card, while on deck. Officials must also present current GA Officials certification card at check-in.
- SCRATCH RULE:** Georgia Scratch Rule (adopted 9/23/2006 attached below) will be in effect.
- WARM-UP:** Georgia Swimming warm-up procedures and rules will be followed. Lanes and warm-up times may be assigned and will be posted on the web site and at the pool. A coach with 2010 USAS certification must supervise warm-up.
- LIABILITY:** USA Swimming, Inc., Georgia Swimming, Steve Lundquist Natatorium, Southern Crescent Aquatic Team, and Clayton County Georgia shall be free from any liability or claims for damage arising by reason of injury to anyone during the conduct of this meet. Failure of swimmers, coaches, etc., to follow the direction of the safety marshal may result in their removal from the meet without the refund of entry fees. **THE ATTACHED LIABILITY FORM MUST ACCOMPANY EACH TEAM'S ENTRY.**
- CONCESSIONS:** Basic Concessions appropriate for a swim meet will be available.

SCRATCH RULE

The Scratch Rule used in all meets in Georgia where the meet format has preliminary heats, consolation finals, and finals is the same "Scratch Rule" as that found in the current USA Swimming Rules and Regulations. Certain LSC additions listed below apply to all timed final meets as well.

"D. Scratching from finals:

1. Any swimmer qualifying for a C, B, or A (bonus and consolation final or) final race in an individual event who fails to compete in said final shall be barred from further competition for the remainder of the meet. A declared false start or deliberate delay of meet is not permitted and will be regarded as a failure to compete.
2. In the event of withdrawal or barring of a swimmer from competition the Referee shall fill the C, B, or A (bonus and consolation final or) final, when possible, with the next qualified swimmer(s). First and second alternates shall be announced along with the final qualifiers. These alternates shall not be penalized if unavailable to compete in the finals.
3. Where C and B (bonus and consolation) finals have not been swum and a barring or withdrawal is known to the Referee, the Referee shall re-seed the C, B, or A (bonus final, consolation final or) final, if necessary, to insert the alternate(s) in the appropriate lane(s), filling all lanes in the final.
4. If the C or B (bonus and consolation) final has already been contested, the companion final shall be swum without reseeding for the empty lane(s).

E. Exceptions for failure to compete – No penalty shall apply for failure to withdraw or compete in an individual event if:

1. The Referee is notified in the event of illness or injury and accepts the proof thereof.
2. A swimmer qualifying for a C, B or A (bonus or consolation final or) final race based upon the results of the preliminaries notifies the Referee within thirty (30) minutes after announcement of the qualifiers for that race that they may not intend to compete and further declares their final intentions within thirty (30) minutes following their last individual preliminary event.
3. It is determined by the Referee that failure to compete is caused by circumstances beyond the control of the swimmer."

LSC ADDITIONS:

1. Swimmers that qualify for any additional heats beyond the above mentioned "C, B and A" final races will also be subject to the above rules concerning scratching from finals.

2. In deck seeded events, a swimmer who has checked in, been seeded and fails to compete in said event, shall be barred from his or her next individual event, except as noted in section E above. **This rule also applies in timed finals meets where the meet management has placed limits on the number of heats to be contested or the number of individual entries to be accepted for deck-seeded events, unless otherwise stated in the Meet Information.**

3. There is no scratch rule governing relays and there is no penalty regarding relay scratches.

4. **Qualifiers for all finals heats** and first and second alternates are **those as** identified on the original results of the preliminary heat.

5. The meet official designated to receive initial intentions not to compete and final intentions shall be announced at the beginning of each session. It is suggested that this official be the Clerk of Course.

6. On the final day of LSC Championship competition, any swimmer who has checked in for finals and fails to show will be assessed a \$50 fine. This fine must be paid before the next LSC Championship meet in which the swimmer intends to compete or the swimmer will be barred from competition.

7. "Positive check-in" , (for deck seeding), designating a swimmer's intent to swim a race, shall be denoted by the swimmer's or coach's initials next to the swimmer's name on the official entry sheet posted at the Clerk of Course.
